What is a Portfolio Review?

Here is an opportunity for you to meet with an experienced photo professional to review and discuss your portfolio. You will be offered guidance and suggestions for your images as well as discussing marketing options. Scrutinize the brief biographies and select (in order of preference) the reviewers who can give you the most thorough critique of your photography.

What should I bring to the review?

Bring a portfolio of 100 images...color transparencies in any format and/or prints in color or black & white. Your portfolio should well rep-

resent your photographic talent. No negatives or contact sheets, please.

Each attendee may register for an unlimited number of reviews. Each review is a 20-minute session. Reviews will be assigned according to priority of schedule request, reviewer availability, and receipt of payment. Only one reviewee per 20-minute session, no "couples" for one time slot. Due to the overwhelming number of requested reviews, you will be notified of your scheduled review time(s) in writing by mid-December. You can also sign up for additional reviews (if there is availability) on-site.
